Hebrank ("Receiver"), the Court appointed permanent receiver for Copeland Wealth Management, a Financial Advisory Corporation ("CWM"), 22 Copeland Wealth Management, a Real Estate Corporation ("Copeland Realty"), and 23 their subsidiaries and affiliates (collectively, the "Receivership Entities"), hereby 24 submits his Receiver's Report #7. This Report provides the Court and all interested 25 parties with the status of the Receiver's activities since the issuance of Receiver's 26 27 Report #6 on July 3, 2013. ///// 28

I. THE RECEIVER'S RECENT ACTIVITIES

Since the issuance of the Receiver's Report #6, the following outlines the primary activities of the Receiver.

A. Copeland Realty Business Operations

With the exception of the final distribution of the proceeds for Copeland Properties Eighteen ("CP18"), the Receiver has now settled or abandoned his interest in the remaining Copeland real estate limited partnerships, with approval of the Court. The remaining entities of the receivership estate include Copeland Realty and the Copeland Fixed Income funds.

B. <u>Collection of Notes Receivable</u>

In conjunction with General Counsel, the Receiver has: (1) made demand for payment on certain remaining notes receivable obligations owed to various Receivership Entities; (2) negotiated, documented, and received court approval of a settlement involving a short sale of Receivership property; (3) obtained a Default Judgment against notes receiveable account debtor Stauffer's Landscape, Inc. ("Stauffer's"); and (4) commenced lawsuits against certain notes receiveable account debtors owing money to Receivership Entities.

By Order dated October 4, 2013, the Court approved a settlement between the Receiver, on the one hand, and note receivable account debtor John V. Nizzia, an individual ("Nizzia"), on the other hand (the "Nizzia Settlement"). The Nizzia Settlement involves a secured obligation in the original principal amount of \$150,000.00 ("Obligation") owed by Nizzia to Copeland Fixed Income Two, L.P. In general, the Nizzia Settlement involves a short sale ("Short Sale") of the real property commonly known as 42695 Death Valley Road, Banning, California 92220, in accordance with the terms of an Agreement Regarding Release of Collateral ("Agreement") entered into by the Receiver and Nizzia.

Pursuant to the Agreement, *inter alia*, the Receiver agreed to accept the net proceeds of the Short Sale in an amount no less than \$129,285.32, in full satisfaction

of the Obligation. Upon payment of the settlement amount in full, the Receiver agreed to cancel the Note, deem the Obligation satisfied, and cease further enforcement efforts, including non-judicial foreclosure proceedings. As of the date of this Report, the closing of the Short Sale is imminent.

On September 6, 2013, the Receiver obtained a Judgment in favor of Copeland Realty in the principal amount of \$585,207.10, and a Judgment in favor of Copeland Fixed Income Two, L.P. in the principal amount of \$354,271.06, against Stauffer's Landscape, Inc. in a state court action filed in San Bernardino County. The Receiver is analyzing post judgment collection options including, but not limited to, a judgment debtor examination of the principals of Stauffer's.

On October 11, 2013, the Receiver filed a lawsuit in San Bernardino County Superior Court against note receiveable account debtor Sandra Cox to collect on an outstanding obligation in the principal amount of \$8,287.56, plus interest, owed to Copeland Realty. Sandra Cox was served with the Summons and Complaint on November 1, 2013.

On November 1, 2013, the Receiver filed a lawsuit in Riverside County Superior Court against note receiveable account debtor Samuel D. Gregory to collect on an outstanding obligation in the amount of \$56,252.15, plus interest, owed to Copeland Fixed Income Three, L.P. The Summons and Complaint are currently out for service.

To date, the total amount of \$637,984.99 has been collected, detailed as follows:

- 1. The Receiver has collected \$66,000.00 from Myra and Gordon Peterson;
- 2. The Receiver has collected \$17,907.90 from James Watson;
- 3. The Receiver has collected \$355,000.00 from SoCal Del;
- 4. The Receiver has collected \$117,844.78 from Gina and Scott Spraggins;
- 5. The Receiver has collected \$70,732.31 from Dr. Vellore Muraligopal and the Muraligopal Living Trust;

- 6. The Receiver has collected \$6,000.00 from Bobby Bhasker-Rao; and
- 7. The Receiver has collected \$4,500.00 from Venkatasvara Rao.

As explained in previous reports filed by the Receiver, several of the settlements negotiated involve installment payments, at least one of which extends out as far as two years. Receiver's General Counsel is continuing to pursue additional settlements and various other remedies on certain of the remaining notes receivables outstanding, in addition to those detailed above.

C. Proofs of Claim & Planned Distributions

An order granting the Receiver's motion for establishing a claims bar date and procedures for submitting proofs of claims was approved by the Court on January 2, 2013. Creditors had until March 3, 2013 to file claims against the Receivership Entities. The Receiver has analyzed and prepared a claims summary for each Receivership Entity.

In that the Court denied the Motion to Consolidate Receivership Entities and Pool Assets and Liabilities of Receivership Entities, it is anticipated that any final distributions will be made based upon a specific Receivership Entity basis. At this time, the Receiver does not anticipate any distributions being made to the following entities because they were either (1) not viable entities at the time of the receivership (some properties had already been lost to foreclosure or another receivership) and/or (2) the entities were already "closed out", inactive or were pass-through tax entities at the time of the receivership: Copeland Realty, Inc.; Copeland Private Equity One, L.P.; Copeland Private Equity Two, L.P.; Copeland Properties One, L.P.; Copeland Properties Three, L.P.; Copeland Properties Four, L.P.; Copeland Properties Six, L.P.; Copeland Properties Eight, L.P.; Copeland Properties Eleven, L.P.; Copeland Properties Twelve, L.P.; Copeland Properties Thirteen, L.P.; and Copeland Properties Fourteen, L.P.; Copeland Properties Fourteen, L.P.

On October 18, 2013, the Receiver filed a Motion for Order Approving Future Distributions of the Assets of Copeland Fixed Income One, LP, Copeland RECEIVER'S REPORT #7

Fixed Income Two, LP and Copeland Fixed Income Three, LP, whereby the Receiver proposed to the Court a plan to make future distributions to the limited partners of each Copeland Fixed Income Fund ("Fixed Income Limited Partners") based upon their pro rata ownership interests. On October 18, 2013, the Receiver also filed a Motion for Order Approving Classification of Claims and Future Claims Distributions of the Assets of Copeland Realty, whereby the Receiver proposes to distribute the assets of Copeland Realty based on the priority of claims. The hearing date on these motions was originally set for November 18, 2013, but was continued on the Court's own motion to November 25, 2013, and then to December 16, 2013.

Assuming these motions are approved by the Court on December 16, 2013, the Receiver anticipates making distributions to the Fixed Income Limited Partners based upon the predetermined percentages approved by the Court, and to certain claimants of Copeland Realty based upon the claims approved by the Court, as part of the wrap-up of the receivership. A future Liquidating Trustee, as proposed later in this Report, would be able to make any future distributions based upon court approval of the relief sought in these motions.

D. Forensic Accounting Status

The Receiver issued his final forensic accounting report on Defendant Copeland's financial activities on August 12, 2013. This report focused on all transactions involving Defendant Copeland, which were reviewed and analyzed to determine funds and other consideration they received from the Receivership Entities.

E. <u>Legal Matters</u>

Since the last Receiver's Report, Mulvaney Barry Beatty Linn & Mayers ("Mulvaney Barry"), as General Counsel for the Receiver, has represented the Receiver in numerous legal matters involving the Receivership Estate including, but not limited to, the following:

- 1. <u>General Representation</u> Represented and assisted the Receiver in general receivership matters including communications with investors and their representatives, communications with the Securities and Exchange Commission, responding to inquiries from lenders and their counsel on the various partnership properties, and review of the Receiver's fee applications.
- 2. <u>Sales and Transfers of Properties</u> Represented the Receiver in connection with the sale or transfer of Receivership partnership properties, and follow up on properties previously sold or abandoned pursuant to Court orders.
- 3. <u>Disposition of Certain Properties</u> Represented the Receiver in facilitating compliance with the settlement agreements approved by the Court between the Receiver and the limited partnerships Copeland Properties Two, LP, Copeland Properties Five, LP, Copeland Properties Seven, LP, Copeland Properties 16, LP and Copeland Properties 17, LP.
- 4. <u>CP10 Settlement and Distribution</u> Coordinated the final distribution of funds to CP10's investors and lender, following approved by the Court of a motion for the distribution of certain assets with respect to the disposition of CP10's Troy, Michigan property.
- 5. <u>CP18 Post-Sale Issues</u> Resolved claims by CP18's lender for default interest, attorney's fees and a loan payoff adjustment, and negotiated a settlement agreement. Filed a motion for approval of the settlement, which was granted by the Court, and thereafter, Mulvaney Barry coordinated distribution of the disputed funds by the escrow company to the lender and Receiver.
- 6. <u>CP18 Distribution</u> Analyzed claims against CP18 and worked with Receiver to prepare a distribution schedule of CP18 assets to its investors and creditors. Filed a motion for Court approval of the Receiver's proposed distribution of CP18's assets, and prepared replies to extensive oppositions to the motion filed by certain CP18 limited partners that previously were investors in CP3 and by Tri Tool, Inc. ("Tri Tool"), the purchaser of CP3's property. The motion was granted RECEIVER'S REPORT #7

- by order dated November 5, 2013, except as to Tri Tool, and in that regard the Court continued the hearing and requested further briefing. Thereafter, Mulvaney Barry prepared the court-ordered supplement briefing concerning alleged fraudulent transfers to CP18. The remainder of the motion for distribution of CP18's assets is pending before the Court, to be heard December 16, 2013.
- 7. <u>Tri Tool's Motion to Modify Stay</u> Prepared opposition to a motion for relief from the stay in this action, filed by Tri Tool, which would have allowed Tri Tool to bring claims in state court against CP18, CP14 and Copeland Realty. The motion was joined by certain former limited partners in CP3, most of whom became investors in CP18. The Court denied Tri Tool's motion.
- 8. <u>Notes Receivable</u> Continued collection efforts on the various Notes Receivable owed to various Receivership entities by third parties, resulting in agreements for payment pursuant to a short sale of Receivership property, a Judgment obtained against a note receiveable account debtor, and the initiation of two lawsuits. Prepared a motion approved by the Court for approval of the Nizzia Settlement. Prepared and filed two state court collection actions against Notes Receiveable Account Debtors Samuel Gregory and Sandra Cox, as explained in greater detail above. Obtained a Judgment in favor of Copeland Realty in the principal amount of \$585,207.10, and in favor of Copeland Fixed Income Two, L.P. in the principal amount of \$354,271.06, against Note Receiveable Account Debtor Stauffer's Landscape, Inc. in a state court action filed in San Bernardino County.
- 9. <u>Pending Litigation</u> Continued to monitor pending litigation involving the Receivership entities and to negotiate settlements and possible terms for settlements of the following cases:
 - a. <u>Racine v. Copeland</u> Evaluated the status of the case, including claims against CWM and Copeland Realty, and communicated with plaintiff's counsel reasons the action should be dismissed as to these

Receivership Entities. Plaintiff's counsel has confirmed dismissal of the action as to the Receivership Entities.

- b. <u>Shelton v. Copeland</u> Evaluated the status of the case, including claims against CWM and Copeland Realty, and communicated with plaintiff's counsel reasons the action should be dismissed as to these Receivership Entities. Plaintiff's counsel has confirmed dismissal of the action as to the Receivership Entities.
- c. <u>German American Capital v. Copeland</u> Evaluated the status of the case, including the cross-complaint by Rancho Mirage Surgery Center ("RMSC") against Receivership Entity, Copeland Private Equity Two ("CPET"), and potential claims by CPET, Copeland Fixed Income One and Copeland Fixed Income Three against RMSC. Mulvaney Barry currently is negotiating a possible mutual dismissal of all claims and cross-claims, which would be brought before the Court for approval.
- d. <u>Tri Tool v. Copeland</u> Evaluated the status of the case in conjunction with Tri Tool's motion to modify the stay, discussed above. Despite numerous discussions and exchanges of email between Mulvaney Barry and counsel for Tri Tool and for the other defendants, a settlement was not reached that would allow dismissal of the Receivership Entity Copeland Properties Three, L.P.
- 10. Future Distributions to Fixed Income Funds and Copeland Realty Prepared and filed two separate Motions as follows: (1) a Motion for Order Approving Future Distributions of the Assets of Copeland Fixed Income One, LP, Copeland Fixed Income Two, LP and Copeland Fixed Income Three, LP; and (2) a Motion for Order Approving Classification of Claims and Future Claims Distributions of the Assets of Copeland Realty. The hearing date on these Motions is currently scheduled for December 16, 2013.

11. Motion for Order Approving Receiver's Final Report and Accounting,

Discharging the Receiver, and Requesting Ancillary Relief – Commenced preparation of a Motion for Order Approving the Receiver's Final Report and Accounting, and Discharging the Receiver. The Motion will also seek additional and related relief including, but not limited to, authorization to appoint a Liquidating Trustee to handle post-receivership tasks.

II. CASH ACTIVITY IN RECEIVERSHIP ACCOUNTS

Attached as Exhibit "A" is a summary of the cash balance in the receivership bank accounts, and attached as Exhibit "B" are Profit & Loss Statements for the period of June 1, 2013, through October 31, 2013. The total cash balance across all accounts as of October 31, 2013 was \$3,870,149.02.

III. REMAINING ACTIVITIES OF THE RECEIVERSHIP

At the June 3, 2013 hearing on numerous motions before the Court in this matter, the Court directed the Receiver to outline the remaining issues involving this case as well as an estimated timeline for completing the outstanding tasks. The following remain as the significant outstanding items in this case:

- Resolve remaining claims in order to distribute the CP18 sales proceeds
- Settle and/or collect the remaining notes receivables for the Receivership Entities
- Collect outstanding notes receivable settlements involving installment payment plans
- Make distributions to investors of the Copeland Fixed Income Funds and claimants of Copeland Realty
- Prepare the 2013 and final tax returns for the Receivership Entities
- Appoint a Liquidating Trustee

In Receiver's Report #6, the Receiver reported that, with the exception of collecting and distributing future payments on notes receivable settlements and final RECEIVER'S REPORT #7

administrative matters such as tax return preparation, that the Receivership Entities' remaining activities could be substantially completed on or before December 31, 2013. Since that time, objections from parties, including some that are not investors in CP18, have caused delays in finalizing the distribution of the CP18 sales proceeds. In addition, the hearing on the Receiver's proposed distribution schedule to the Copeland Realty Claimants and the Copeland Fixed Income Fund investors was also delayed, thus postponing the Receiver's ability to calculate and propose a distribution to these limited partners as well. The Court has scheduled a hearing for December 16, 2013 to rule on these outstanding matters; however, this has caused delays in moving forward on the remaining receivership wrap-up items.

The Receiver is in the process of identifying potential third party liquidating trustees or agents that he intends to recommend to the Court be appointed to oversee any remaining collections and distributions, to oversee final administrative matters such as tax returns, and to address any unforeseen additional matters that may arise after the Receiver is discharged. The Receiver intends to obtain three (3) proposals for the Court's consideration as liquidating trustee or agent.

The Receiver originally proposed ending the receivership prior to year-end. However with the delays described above, the required notice period, and the Court's ability to hear these matters, the Receiver now plans to file final motions for hearing on the Court's February 3, 2014 calendar.
