Thomas C. Hebrank ("Receiver"), the Court-appointed permanent receiver for 1 Copeland Wealth Management, a Financial Advisory Corporation ("CWM"), 2 3 Copeland Wealth Management, a Real Estate Corporation ("Copeland Realty"), and their subsidiaries and affiliates (collectively, the "Receivership Entities"), hereby 4 5 submits his tenth and final application for approval and payment of fees and reimbursement of expenses. This application covers fees and costs incurred during 6 the period January 1, 2014 through the end of the receivership (the "Application") 7 Period"). 8

9 The Receiver has incurred \$29,000.25 in actual and estimated final fees and \$2,124.40 in actual and estimated final costs for this Application Period. Detailed 10 11 descriptions of the services rendered are contained in Exhibit A attached hereto. Exhibit B is a chart reflecting the hours and fees billed to each category of services 12 on a monthly basis during the Application Period. Exhibit C is a summary of the 13 out-of-pocket costs. During the Application Period, the Receiver and his staff have 14 spent and estimated wrap-up time totaling 154.8 hours at an overall blended billing 15 rate of \$187.34 per hour. The Receiver has discounted all fees by ten percent (10%) 16 from regular hourly billing rates. 17

I. OVERVIEW

A detailed description of the history and status of the case is contained in the
Receiver's Final Accounting and Report, which has been filed concurrently with this
Final Fee Application. The following is an overview of the Receivership case for
the Application Period.

A. <u>Copeland Realty Business Operations</u>

26 The Receiver has now either settled or abandoned his interest in the Real
27 Estate Limited Partnerships, either to the remaining limited partners or to the lender,
28

with approval from the Court. The activity relating to the Real Estate Limited
 Partnerships during this Application Period was as follows:

1. Copeland Properties Eighteen ("CP18") – The Court approved a sale of the 3 property which closed on December 7, 2012 for \$8,550,000.00. The sale was 4 5 complicated by the lender on the property, as well as various other parties who also claimed an interest in the CP18 sales proceeds. A settlement was negotiated with 6 the lender, and approved by the Court on September 30, 2013. Various motions 7 were filed and pending with the Court for resolution of the claims by the other 8 parties in this matter. Extensive time was spent in responding to these claims and 9 the various related appeals. After numerous claims and appeals by Tri Tool, the 10 11 Court on January 9, 2014, denied Tri-Tool's final appeal. The Receiver made the 12 final distributions to the CP18 partners and other parties shortly thereafter, as 13 previously approved by the Court.

B. <u>Notes Receivable Recoveries</u>

In conjunction with General Counsel, the Receiver has made demand for
payment, has collected some obligations in full, and in other cases has negotiated
settlements with account debtors to collect on notes receivables owed to various
Receivership entities. To date, the total amount of \$1,428,408.88 has been
collected, detailed as follows:

C. <u>Proof of Claims and Planned Distributions</u>

2 During the Application Period, the Receiver prepared distribution schedules 3 and filed motions with the Court addressing distributions planned for the Copeland Fixed Income and Copeland Wealth Management entities. The Court approved 4 5 these motions on January 2, 2014. The Receiver proposed distributions for Copeland Fixed Income Two, L.P. and Copeland Fixed Income Three, L.P. on 6 March 7, 2014. Sufficient funds do not exist for a distribution for Copeland Fixed 7 Income One, L.P. The Court approved these distributions on April 7, 2014. 8 Concurrent with this Fee Application, the Receiver is proposing a distribution for 9 Copeland Wealth Management. 10

D. <u>Wrap-up of the Receivership</u>

The Receiver has been working with General Counsel to wrap-up the receivership and proposes turning over the remaining tasks to a liquidating trustee, with approval by the Court. The Receiver has identified potential third party liquidating trustees or agents that he intends to recommend to the Court to be appointed to oversee any remaining collections and distributions, to oversee final administrative matters such as tax returns, and to address any unforeseen additional matters that may arise the Receiver is discharged.

The Receiver originally proposed ending the receivership prior to year-end, and then in February 2014. However with the delays relating to Tri Tool and the CP18 appeals, the wrap-up of the receivership was further delayed. Tri Tool filed an additional appeal on February 13, 2014. The Receiver is filing his Final Accounting and Report concurrent with this Fee Application, and has included estimates of final costs in this application.

THE REQUESTED FEES ARE REASONABLE AND SHOULD BE** 18 **ALLOWED** 19 20 **Efficient Staffing – Customary Rates** A. 21 The Receiver believes his request is fair and reasonable and that the fees and 22 costs incurred were necessary to the administration of the receivership estate. The 23 Receiver's request for compensation is based on its customary billing rates charged 24 in similar matters, discounted by ten percent (10%). The blended hourly rate for all 25 services provided by the Receiver during the Application Period is \$187.34. The 26 Receiver's billing rates are comparable or less than those charged in the community 27 on similarly complex matters. Although the Receiver reviews his hourly rates and 28

1 adjusts them annually on January 1 to reflect greater experience and expertise,

2 additional costs of operation, and comparable rates in the marketplace for

3 competitive receivership firms, no rate adjustment has been made for the duration of4 this receivership.

B. <u>Costs</u>

7 The Receiver also requests Court approval of \$2,124.40 in costs. A summary
8 of costs is included as Exhibit C. The Receiver charges \$.15 per page for copies and
9 all other items are billed at actual cost.

The Receiver is proposing to discount the holdbacks in this case by a further 10% (in addition to the 10% discount from regular hourly billing rates), thus requesting approval for payment of \$127,070.53 in
