26 The following table summarizes the interim payments and costs requested from

In addition to the fees requested, Sullivan Hill performed additional services resulting in charges of \$11,748.50 for which it is **NOT** seeking compensation.

Sullivan Hill has also discounted the hourly rates of its professionals by 10 percent, and has agreed that at the time of its final fee application, the firm's blended hourly rate for all professionals will not exceed \$360 per hour. This discount saved the estates \$2,169.04 ($\$21,690.40 \times .10$) during the period covered by this application.
