1 Thomas C. Hebrank ("Receiver"), the Court-appointed receiver for First
2 Financial Planning Corporation d/b/a Western Financial Planning Corporation
3 ("Western"), its subsidiaries and the General Partnerships listed in Schedule 1 to the
4 Preliminary Injunction Order entered on March 13, 2013 (collectively,
5 "Receivership Entities"), files this errata and corrects his motion for an order
6 approving the sale of the Honey Springs property and authority to pay the real estate
7 broker's commission ("Motion"). (Dkt. No. 1430.)

8 At page 7, lines 7-27, the Receiver discusses the overbid procedures related to
9 the sale of the Honey Springs property. Specifically, the Receiver states that the
10 deadline for prospective bidders to submit their materials to the Receiver in order to
11 qualify to bid is February 6, 2017, and the auction will take place on February 7,
12 2017, at 1:30 p.m.

13 This bid qualification deadline and auction date are incorrect and are hereby
14 by replaced as follows: (i) the bid qualification deadline is February 13, 2017, and
15 (ii) the auction date is February 14, 2017, at 1:30 p.m. The notice being published
16 in the San Diego Union-Tribune pursuant to 28 U.S.C. §§ 2001, 2002 states the
17 corrected bid qualification deadline and auction date. These corrections do not
18 otherwise alter any facts or other statements contained in the Motion.
