1 **PLEASE TAKE NOTICE** that Thomas C. Hebrank ("Receiver"), the Court-
2 appointed receiver for First Financial Planning Corporation d/b/a Western Financial
3 Planning Corporation ("Western"), its subsidiaries and the General Partnerships
4 listed in Schedule 1 to the Preliminary Injunction Order entered on March 13, 2013
5 (collectively, "Receivership Entities"), hereby withdraws his motion for an order
6 approving the sale of the Freetrade/Suntec/Via 188 property and authority to pay the
7 real estate broker's commission.

8 The prospective purchaser terminated the contract after removing all
9 contingencies, surrendering his right to his earnest money deposit. The Receiver is
10 currently attempting to obtain the deposit from escrow with the prospective
