1 Thomas C. Hebrank ("Receiver"), Court-appointed receiver for First Financial
2 Planning Corporation d/b/a Western Financial Planning Corporation ("Western"),
3 and other specifically listed entities (collectively, "Receivership Entities"), submits
4 this Fourth Interim Report on his activities. This report should be read in
5 conjunction with the Receiver's three prior interim reports, Docket Nos. 27, 49
6 and 80. This report focuses on the Receiver's activities during the first quarter
7 of 2013.

8 I. EXECUTIVE SUMMARY

9 The Receiver has continued his work to preserve and protect the assets of the
10 Receivership Entities, including conducting an investigation as necessary to
11 identify, marshal and preserve assets. Pursuant to the Court's orders, the Receiver
12 has also completed a substantial portion of the forensic accounting of Western and
13 the General Partnerships ("GPs"). Part one of the Receiver's Forensic Accounting
14 Report was filed on April 18, 2013. Docket No. 182.

15 The Receiver anticipated having appraisals for the 22 properties owned by the
16 GPs by the time of this report. Some of the appraisers, however, have taken longer
17 than expected to complete their valuation analysis. Nevertheless, the Receiver
18 anticipates having all of the appraisals in the next 30 days and will file a report at
19 that time that includes the appraised value of each property along with the amount
20 owed on each mortgage and other information relevant to determining the ultimate
21 disposition of each property. The report will include a recommended course of
22 action to sell or otherwise dispose of the GP properties (including possibly having
23 the GPs vote on the disposition of their respective properties). A course of action
24 needs to be determined soon because amounts collected from investors each month
25 are insufficient to make the monthly payments on loans secured by GP properties
26 and to pay Western's basic operating expenses. Prior to the Receiver's appointment,
27 Western covered the shortfall with infusions of capital from Mr. Schooler, which
28

1 totaled over \$1 million in 2012, as well as new cash from investors from ongoing
2 sales of GP ownership units. These cash infusions are no longer being made and
3 sales of GP ownership units ceased as of the Receiver's appointment. In order to
4 address this problem, the Receiver obtained authority to sell two cars and certain
5 gold coins owned by Western to generate cash for mortgage payments. These sales,
6 however, will only generate enough cash to make mortgage payments for the next
7 few weeks. Accordingly, a plan for selling or otherwise disposing of the properties
8 is needed soon before the loans go into default and costs associated with such
9 defaults are incurred.

10 **II. SUMMARY OF RECEIVER'S ACTIVITIES**

11 As noted above, the Receiver's primary focus since his appointment has been
12 on identifying, marshalling and preserving the Receivership Entities' assets. These
13 activities fall into the following general categories:

14 **1. Business Operations**

15 The Receiver has continued to operate the Receivership Entities, carry out
16 Western's traditional duties with regard to the GPs, and reduce Western's operating
17 expenses. Western's payroll has been significantly reduced (it no longer has any
18 salaried employees; those retained are being paid on an hourly consulting basis), it is
19 no longer paying rent to LSV III (an entity controlled by Mr. Schooler) for its
20 limited use of the premises located at 5186 Carroll Canyon Road, San Diego, and it
21 is no longer paying legal expenses (other than as approved by the Court in
22 connection with the receivership). This has substantially reduced Western's
23 operating expenses and, together with Court-approved cash transfers from
24 Mr. Schooler and cash generated from Court-approved sales, has allowed Western
25 to timely make all post-receivership payments on mortgages secured by GP
26 properties.

27 With assistance of Western personnel and the accounting firm of Duffy
28 Kruspodin & Company LLP, the Receiver completed the 2012 tax returns for the

1 GPs and issued K-1s to all investors on or about April 2, 2013. The Receiver has
2 obtained an extension for Western's tax returns.

3 2. Asset Investigation & Recovery

4 The Receiver has investigated various assets reflected on Western's books and
5 records, including the following:

6 **Notes Payable from LinMar Entities.** Western's books and records reflect
7 that it made loans to LinMar Management, Inc., LinMar Shaw, LLC,
8 LinMar III, LLC, LinMar IV, LLC and approximately 16 LinMar Tacoma entities
9 (collectively, "LinMar Borrowers"). The Receiver's understanding is that the
10 LinMar Borrowers are managed by Mr. Schooler or entities he controls. All of the
11 loans have matured. The aggregate amount owing on the notes is approximately
12 \$1.266 million. With the exception of the LinMar Tacoma loan, the loans all appear
13 to be unsecured.

14 The Receiver issued a demand to the LinMar Borrowers for full payment of
15 the loans and also issued subpoenas to the LinMar Borrowers and Mr. Schooler
16 seeking documents relevant to his investigation of the loans. Mr. Schooler has
17 produced certain documents in response to the subpoenas, which documents are
18 being reviewed by the Receiver. Mr. Schooler recently made a proposal for
19 repayment of the loans. The Receiver sent a counter-proposal to Mr. Schooler's
20 counsel on April 24, 2013.

21 The Receiver will attempt to reach an agreement concerning repayment of the
22 loans. If such an agreement cannot be reached in the near future, the Receiver will
23 seek appropriate relief from the Court, including a request for authority to file
24 actions against the LinMar Borrowers to collect on the loans.

25 **Automobiles.** As noted above, the Court authorized the Receiver to sell the
26 two automobiles owned by Western. Docket No. 180. The Receiver sold the
27 1998 Lexus to Mr. Schooler for \$12,000. The 2008 Lexus is expected to be sold by
28 auction in the next few weeks.

1 Company, a public utility company ("Sierra Pacific"). Although Sierra Pacific
2 successfully condemned the relevant portion of the property and paid approximately
3 \$4.4 million to the applicable GPs as compensation, an appeal is pending and Sierra
4 Pacific has now sought to abandon the condemned property and obtain return of the
5 funds. Approximately \$515,000 of the \$4.4 million was used to pay legal,
6 engineering and appraisal costs associated with the litigation. The vast majority of
7 the remaining \$3.9 million was distributed to the general partners of the four GPs
8 involved.

9 The Receiver has engaged Sierra Pacific in settlement discussions. If a
10 settlement can be reached, the Receiver will seek Court approval of such settlement
11 via noticed motion.

12 IV. REAL ESTATE EVALUATION

13 Pursuant to the Court's Order Re Receiver's Second Report and Proposal
14 (Docket No. 59), the Receiver engaged licensed real estate appraisers to provide an
15 independent opinion of value for the Receivership Entities' 22 real properties (one
16 opinion for each property). The Receiver also reviewed the mortgages associated
17 with each property and talked to the applicable lenders to determine the exact
18 amounts owed for each property.

19 As noted above, the appraisers have taken longer than expected to complete
20 their reports. Nevertheless, the Receiver anticipates having the appraisals in the
21 next 30 days and will file a report at that time that includes the appraised value of
22 each property along with the amount owed on each mortgage and other information
23 relevant to determining the ultimate disposition of each property.

24 V. FORENSIC ACCOUNTING

25 The Receiver has completed a substantial portion of his forensic accounting
26 and analysis of the Receivership Entities. The project includes testing the data and
27 records maintained by Western for accuracy and reliability and then compiling and
28 analyzing the data to create a summary of the Receivership Entities' financial

1 transactions. The project is time consuming due to the number of entities and the
2 volume of transactions.

3 Part One of the Receiver's Forensic Accounting Report was filed on April 18,
4 2013. Docket No. 182. Part One covers the funds raised by investors of the final
5 46 GPs set up by Western, Western's purchase and sale of 13 properties relating to
6 those 46 GPs, and the transfer of the remaining investor funds to Western. In
7 summary, Western raised approximately \$108 million from investors for these
8 46 GPs, for land which it purchased for \$21 million (only \$7 million of which was
9 cash and the remainder of which was notes for which the GPs are ultimately
10 responsible). Part Two of the report, if authorized by the Court, will cover
11 Western's use of the approximately \$80 million in excess proceeds it received from
12 investors of the 46 GPs covered in Part One.

13 VI. RECEIPTS AND DISBURSEMENTS

14 Attached hereto as Exhibit A is a summary of the receipts and disbursements
15 for the Receivership Entities for the period January 1, 2013 through March 31, 2013.
16 Although the summary reflects \$151,032.94 in Western accounts (see Total WFPC
17 Bank Accounts), the majority of these funds have since been used to make mortgage
18 payments and pay other basic operating expenses.

19 Attached as Exhibit B are (1) a Profit and Loss statement for Western for the
20 period January 1, 2013 through March 31, 2013, and (2) Balance Sheets and Profit
21 and Loss statements for Real Asset Locators, Inc. for the year ending February 28,
22 2013, and the month ending March 31, 2013. These statements were prepared on a
23 cash basis by Western accounting personnel.

24 VII. INVESTOR COMMUNICATIONS

25 The Receiver has continued to update his website, www.ethreadvisors.com,
26 with his reports, briefs filed by the parties that pertain directly to the receivership,
27 and Court orders. The Receiver and his staff have also promptly responded to all
28

1 inquiries from investors and other interested parties. As noted above, K-1 tax forms
2 for 2012 have been sent to all investors.

3 Attached hereto as Exhibit C is a redacted schedule of investor claims
4 pursuant to Local Rule 66.1.e. and the Court's Order Granting In Part Unopposed
5 Motion for Relief from Requirements of Local Rule 66.1 (Docket No. 170). The
6 unredacted schedule will be filed separately under seal such that investor addresses
7 are kept confidential. Investors are reminded of the importance of informing the
8 Receiver of any change in their address.

9 **VIII. RECOMMENDATIONS FOR RECEIVERSHIP**

10 The Receiver recommends that the receivership continue pursuant to the
11 Court's orders. The Receiver will continue to investigate, preserve and protect the
12 Receivership Entities' assets, and will complete his forensic accounting and
13 evaluation of real estate assets. As discussed above, the Receiver will file a report
14 on his evaluation of the GP properties, along with recommendations relating thereto,
15 in approximately 30 days.

16 As the receivership progresses, the Receiver will evaluate the appropriate
17 method for receiving and analyzing investor claims, as well as the most equitable
18 and efficient manner of distributing assets of the receivership estate to those with
19 valid claims. At the appropriate time, the Receiver will seek Court approval of
20 procedures for determining claims and a plan of distribution.

21 **IX. CONCLUSION**

22 Based on the foregoing, the Receiver requests approval of this Fourth Interim
23 Report and his recommendations discussed above.


