2 Thomas Hebrank ("Receiver"), the Court-appointed receiver for Defendant PWCG
3 Trust, for Payment of Fees and Reimbursement of Expenses ("Application"),
4 including any supporting declarations and objections filed therein, and being so
5 advised in the matter and finding good cause, orders as follows:

6 **IT IS ORDERED** that the Receiver's Application is granted.
