1 The First Interim Fee Application of Allen Matkins Leck Gamble Mallory &
2 Natsis LLP, General Counsel to the Receiver, for Payment of Fees and
3 Reimbursement of Expenses ("Application") filed by Allen Matkins Leck Gamble
4 Mallory & Natsis LLP ("Allen Matkins"), general counsel to Thomas Hebrank, the
5 Court-appointed receiver for Defendant PWCG Trust, was set for hearing on
6 September 20, 2018. No oppositions were filed by the deadline. See Local Rule
7 7-9.

8 The Court having reviewed the Application, and finding good cause, orders as
9 follows:

10 **IT IS ORDERED** that the Application of Allen Matkins is **granted**.

11 **IT IS FURTHER ORDERED** that Allen Matkins' fees and costs for the First
12 Application Period are allowed and approved, on an interim basis, in the amounts of
13 \$76,835.70 and \$1,545.16, respectively.

14 **IT IS FURTHER ORDERED** that the Receiver is authorized and directed to
15 pay Allen Matkins \$61,468.56 in fees and \$1,545.16 in costs from assets of the
16 receivership estate, which amounts reflect an interim payment of 80% of the
17 allowed fees and 100% of the allowed costs.
