Allen Matkins Leck Gamble Mallory & Natsis LLP ("Allen Matkins"), general counsel to Thomas Hebrank ("Receiver"), the Court-appointed receiver for PWCG Trust, hereby submits this seventeenth interim application for approval and payment of fees and reimbursement of expenses ("Application"). This Application covers the period from January 1, 2022, through March 31, 2022 ("Seventeenth Application Period"), and seeks interim approval of \$174,879.45 in fees and \$7,319.29 in expenses, and an order authorizing the Receiver to pay, on an interim basis, 80% of the fees incurred (\$139,903.56) and 100% of expenses incurred.

### I. INTRODUCTION

This equity receivership was established pursuant to the Consent of Defendant PWCG Trust filed on February 12, 2018, and the Judgment as to Defendant PWCG Trust ("Appointment Order") entered on February 16, 2018. Dkt. Nos. 143, 145. The Appointment Order confers full powers of an equity receiver, including full power over all funds, assets, and other property of PWCG Trust, and including its bank accounts, life insurance policies ("Policies"), books and records, and all funds and assets controlled or managed by PWCG Trust. The Appointment Order also authorizes the Receiver to "engage and employ attorneys, accountants, and other persons" to assist him in the performance of his duties. Dkt. No. 145, Section III(F).

The Receiver promptly determined that his experienced staff at E3 Realty Advisors, Inc., dba E3 Advisors ("E3"), as well as experienced, qualified counsel was critical due to the number of people involved, the amount at stake for investors, the transactional volume, and the complex issues facing PWCG Trust. Accordingly, the Receiver has cost-effectively used his team at E3 to assist in carrying out receivership duties, as well as Allen Matkins as his counsel.

In an abundance of caution, the Receiver sought specific Court approval of Allen Matkins' employment, which was approved on April 10, 2018. Dkt. Nos. 150,

152. The Court also approved the Receiver's proposal to file reports and fee applications on a quarterly basis. *Id*.

#### II. FEE APPLICATION

This fee application should be read in conjunction with the Receiver's Seventeenth Interim Report ("Sixteenth Report") filed on May 17, 2022 (Dkt. No. 481), which describes in detail the Receiver's activities during the Seventeenth Application Period. This Application seeks interim approval of \$174,879.45 in fees for a total of 250.00 hours worked, and payment on an interim basis of 80% of that amount, or \$139,903.56. The work performed is described task-by-task on Exhibit A and is broken down into the following categories:

Allen Matkins has worked diligently and efficiently to assist the Receiver to address legal issues facing the receivership estate. The firm's work has allowed the Receiver to preserve and protect the substantial value of receivership estate assets. Allen Matkins' work has assisted the Receiver in carrying out his Court-ordered duties and the firm should be compensated on an interim basis.

### III. SUMMARY OF TASKS PERFORMED AND COSTS INCURRED

### A. <u>Categories and Descriptions of Work</u>

### 1. <u>General Receivership</u>

Allen Matkins' time in this category focused on assisting and advising the Receiver regarding the production of documents in response to subpoenas issued to

the Receiver and his servicing agent (ITM TwentyFirst) by the remaining Defendants in the case, including addressing confidential information contained on documents produced through a protective order. The reasonable and necessary fees for work in this category total \$5,994.45.

### 2. Reporting

Allen Matkins' time in this category focused on preparing the Receiver's Sixteenth Interim Report. Dkt. 455. The report contains detailed descriptions of the Receiver's activities during the third quarter of 2021, policy maturities, investor communications, pending litigation, tax issues, and post-receivership receipts and disbursements. The report also includes the Receiver's recommendations for the continued administration of the receivership estate. Attorney David Zaro also attended the hearing held by the Court on February 7, 2022. The reasonable and necessary fees for work in this category total \$5,645.70.

### 3. <u>Claims & Distributions</u>

Allen Matkins assisted the Receiver in addressing issues relating to the death of an investor claimant and the change to the holder of the claim to the representative of his probate estate. The reasonable and necessary fees for work in this category total \$128.70.

### 4. Employment/Fees

Although fee applications are a necessary component of federal equity receiverships, Allen Matkins does not charge any time for preparing its own fee applications. The firm assisted the Receiver and his tax accountants, Duffy Kruspodin, in preparing their fee applications, and attorney David Zaro attended the hearing held on February 14, 2022. The reasonable and necessary fees for work in this category total \$1,525.50.

### 5. MP&C Litigation<sup>1</sup>

The vast majority of Allen Matkins' work during the Seventeenth Application Period focused on prosecuting the Receiver's claims against Mills Potoczak & Company ("MPC") on behalf of PWCG Trust (the Receiver's Complaint against MPC was previously filed on September 3, 2020). The firm's diligent work during the first quarter, in coordination with counsel for the putative investor class, directly lead to the very favorable settlement of the case against MPC for \$9.75 million settlement out of \$10 million in available insurance coverage (\$5 million in primary coverage and \$5 million in excess coverage). A motion to approve the Settlement Agreement will be filed soon.

The Receiver, the investor-plaintiffs and MPC attended mediation with the Hon. Raymond J. Ikola (Ret.) of JAMS on January 13, 2022. Allen Matkins prepared the Receiver's mediation brief, participated on a pre-mediation call with Justice Ikola, attend the full-day mediation, and communicated with counsel for MPC and counsel for the investor-plaintiffs regarding the MPC insurance coverage issues, settlement, mediation issues, as well as the scheduling of further discovery for after the mediation. The case did not settle at mediation, and MPC promptly filed a declaratory relief action to address the disputed issues of insurance coverage raised during the mediation. The Receiver and the putative investor class also issued a second joint settlement demand on MPC for the limits of its available insurance coverage.

Allen Matkins continued to assist the Receiver in moving the case forward, including noticing, preparing for, and taking the deposition of MPC's person most knowledgeable, William Potoczak. The firm also handled communications with the expert witness the Receiver planned to use and handled the sharing of relevant

An unredacted copy can be provided to the Court upon request for *in camera* review.

documents with counsel for the putative investor class. Allen Matkins analyzed the coverage positions asserted by MPC's respective insurance carriers, which became a significant obstacle to settlement of the case.

Allen Matkins handled negotiations with MPC and its insurance carriers on behalf of the Receiver, including coordinating such negotiations with counsel for the putative investor class. As noted above, these negotiations ultimately resulted in a settlement in which MPC, subject to Court approval, will pay \$9.75 million out of \$10 million in available insurance coverage. The reasonable and necessary fees for work in this category total \$161,585.10.

### B. Summary of Expenses Requested for Reimbursement

Allen Matkins requests the Court approve reimbursement of \$7,319.29 in outof-pocket costs. The itemization of such expenses is summarized below by category.

### FEES AND COSTS INCURRED AND PAID TO DATE

From inception of the receivership through March 31, 2022, the Receiver incurred fees and costs of \$530,220.62, of which amount \$99,564.66 is subject to holdback pending approval of the Receiver's final fee application at the conclusion of the receivership, \$17,224.70 is awaiting the Court's review and approval, and \$416,613.21 has been approved by the Court and paid to date. During the same time period, Allen Matkins has incurred fees and costs of \$1,384,061.27, of which

amount \$270,855.45 is subject to holdback pending approval of Allen Matkins' final fee application at the conclusion of the receivership, \$182,198.74 is awaiting the Court's review and approval, and \$965,982.97 has been approved by the Court and paid to date.

# IV. THE FEES AND COSTS ARE REASONABLE AND SHOULD BE ALLOWED

"As a general rule, the expenses and fees of a receivership are a charge upon the property administered." *Gaskill v. Gordon*, 27 F.3d 248, 251 (7th Cir. 1994). These expenses include the fees and expenses of this Receiver and his professionals, including Allen Matkins. Decisions regarding the timing and amount of an award of fees and costs to the Receiver and his Professionals are committed to the sound discretion of the Court. See *SEC v. Elliot*, 953 F.2d 1560, 1577 (11th Cir. 1992) (rev'd in part on other grounds, 998 F.2d 922 (11th Cir. 1993)).

In allowing fees, a court should consider "the time, labor and skill required, but not necessarily that actually expended, in the proper performance of the duties imposed by the court upon the receiver[], the fair value of such time, labor and skill measured by conservative business standards, the degree of activity, integrity and dispatch with which the work is conducted and the result obtained." *United States v. Code Prods. Corp.*, 362 F. 2d 669, 673 (3d Cir. 1966) (internal quotation marks omitted). In practical terms, receiver and professional compensation thus ultimately rests upon the result of an equitable, multi-factor balancing test involving the "economy of administration, the burden that the estate may be able to bear, the amount of time required, although not necessarily expended, and the overall value of the services to the estate." *In re Imperial 400 Nat'l, Inc.*, 432 F.2d 232, 237 (3d Cir. 1970). Regardless of how this balancing test is formulated, no single factor is determinative and "a reasonable fee is based [upon] all circumstances surrounding the receivership." *SEC v. W.L. Moody & Co., Bankers (Unincorporated)*, 374 F. Supp. 465, 480 (S.D. Tex. 1974).

As a preliminary matter, the Appointment Order confers on the Receiver substantial duties and powers, including to conduct such investigation and discovery as is necessary to locate and account for all receivership assets, take such action as is necessary and appropriate to assume control over and preserve receivership assets, and employ attorneys and others to investigate and, where appropriate, institute, pursue, and prosecute all claims and causes of action of whatever kind and nature. *See* Appointment Order, Section III.

The Receiver promptly determined that experienced, qualified counsel was necessary due to the size and complexity of the receivership estate and the Court agreed, specifically approving Allen Matkins' employment. Dkt. No. 152. The Court also approved the Receiver's proposal to file interim reports and fee applications on a quarterly basis. *Id*.

Allen Matkins has submitted a detailed fee application which describes the nature of the services rendered, and the identity and billing rate of each individual performing each task. *See* Exhibit A. Allen Matkins has endeavored to staff matters as efficiently as possible, while remaining cognizant of the complexity of issues. The request for fees is based on Allen Matkins' customary billing rates charged for comparable services provided in other matters, less a 10% discount. In addition, the firm has written off and not charged for 0.70 hours of time (\$450.45) during the Seventeenth Application Period.

The work performed by Allen Matkins was essential to carrying out the Receiver's Court-ordered duties. The Receiver and Allen Matkins have worked diligently since the Receiver's appointment to preserve and protect the assets of the receivership estate, to investigate potential claims against third parties, and to maximize the funds available for ultimate distribution to investors. Moreover, Allen Matkins seeks payment of only 80% of fees incurred on an interim basis in recognition of the fact that its work in assisting the Receiver is ongoing. Payment of the proposed 20% holdback will be sought at the conclusion of the receivership.
