Allen Matkins Leck Gamble Mallory & Natsis LLP ("Allen Matkins"), 1 general counsel to Thomas Hebrank ("Receiver"), the Court-appointed receiver for 2 PWCG Trust, hereby submits this eighteenth interim application for approval and 3 payment of fees and reimbursement of expenses ("Application"). This Application 4 5 covers the period from July 1, 2022, through September 30, 2022 ("Nineteenth Application Period"), and seeks interim approval of \$71,391.60 in fees and 6 \$2,650.39 in expenses, and an order authorizing the Receiver to pay, on an interim 7 8 basis, 80% of the fees incurred (\$57,113.28) and 100% of expenses incurred.

I. INTRODUCTION

This equity receivership was established pursuant to the Consent of 10 Defendant PWCG Trust filed on February 12, 2018, and the Judgment as to 11 Defendant PWCG Trust ("Appointment Order") entered on February 16, 2018. Dkt. 12 Nos. 143, 145. The Appointment Order confers full powers of an equity receiver, 13 including full power over all funds, assets, and other property of PWCG Trust, and 14 including its bank accounts, life insurance policies ("Policies"), books and records, 15 and all funds and assets controlled or managed by PWCG Trust. The Appointment 16 Order also authorizes the Receiver to "engage and employ attorneys, accountants, 17 and other persons" to assist him in the performance of his duties. Dkt. No. 145, 18 19 Section III(F).

The Receiver promptly determined that his experienced staff at E3 Realty
Advisors, Inc., dba E3 Advisors ("E3"), as well as experienced, qualified counsel
was critical due to the number of people involved, the amount at stake for investors,
the transactional volume, and the complex issues facing PWCG Trust. Accordingly,
the Receiver has cost-effectively used his team at E3 to assist in carrying out
receivership duties, as well as Allen Matkins as his counsel.

In an abundance of caution, the Receiver sought specific Court approval of
Allen Matkins' employment, which was approved on April 10, 2018. Dkt. Nos. 150,

28

1 152. The Court also approved the Receiver's proposal to file reports and fee
 2 applications on a quarterly basis. *Id.*

3

II. FEE APPLICATION

This fee application should be read in conjunction with the Receiver's
Nineteenth Interim Report ("Nineteenth Report") filed on November 10, 2022 (Dkt.
No. 513), which describes in detail the Receiver's activities during the Nineteenth
Application Period. This Application seeks interim approval of \$71,391.60 in fees
for a total of 92 hours worked, and payment on an interim basis of 80% of that
amount, or \$57,113.28. The work performed is described task-by-task on Exhibit A
and is broken down into the following categories:

Allen Matkins has worked diligently and efficiently to assist the Receiver to
address legal issues facing the receivership estate. The firm's work has allowed the
Receiver to preserve and protect the substantial value of receivership estate assets.
Allen Matkins' work has assisted the Receiver in carrying out his Court-ordered
duties and the firm should be compensated on an interim basis.

III. SUMMARY OF TASKS PERFORMED AND COSTS INCURRED

1

A. <u>Categories and Descriptions of Work</u>

1. <u>General Receivership</u>

Allen Matkins' time in this category focused on advising the Receiver
regarding the ongoing litigation between the Securities and Exchange Commission
and the remaining Defendants in the case, including anticipated testimony from the
Receiver at trial. The reasonable and necessary fees for work in this category total
\$1,164.15.

2. <u>Asset Investigation & Recovery</u>

Allen Matkins' time in this category focused on advising the Receiver
regarding the ongoing maintenance and management of life insurance policies
including in the receivership estate. The reasonable and necessary fees for work in
this category total \$626.85.

14

3. <u>Reporting</u>

Allen Matkins' time in this category focused on preparing the Receiver's
Eighteenth Interim Report. Dkt. 499. The report contains detailed descriptions of
the Receiver's activities during the second quarter of 2022, policy maturities,
investor communications, pending litigation, tax issues, and post-receivership
receipts and disbursements. The report also includes the Receiver's
recommendations for the continued administration of the receivership estate. The
reasonable and necessary fees for work in this category total \$1,941.75.

4. <u>Claims & Distributions</u>

Allen Matkins assisted the Receiver in providing updates to investors through
the receivership website. The reasonable and necessary fees for work in this
category total \$3,511.35.

- 5. <u>Employment/Fees</u>

Although fee applications are a necessary component of federal equity
receiverships, Allen Matkins does not charge any time for preparing its own fee

applications. The firm assisted in preparing interim fee applications for the
 Receiver and his tax accountant. The reasonable and necessary fees for work in this
 category total \$619.65.

6. <u>MP&C Litigation¹</u>

5 The majority of Allen Matkins' work during the Nineteenth Application 6 Period focused on the Receiver's claims against Mills Potoczak & Company 7 ("MPC") on behalf of PWCG Trust (the Receiver's Complaint against MPC was 8 previously filed on September 3, 2020) and settlement of those claims. The firm's diligent work during the third quarter, in coordination with counsel for the investor 9 class in the Los Angeles Superior Court ("LASC") cases, directly lead to execution 10 of a favorable Settlement Agreement for \$9.75 million settlement out of \$10 million 11 12 in available insurance coverage (\$5 million in primary coverage and \$5 million in 13 excess coverage).

The Receiver, the class representative plaintiffs and MPC were able to reach a
settlement, subject to Court approval, in March 2022. A settlement agreement was
then drafted that covers, among other things, resolution of the receivership estate's
claims against MPC, resolution of the investor class claims against MPC, approval
by this Court, approval by the LASC (as a class settlement), mutual releases,
payment of class counsel's contingent fee, and distribution of the settlement funds
through the receivership. The settlement agreement could not be signed, however,

21 until MPC had negotiated and executed separate settlements with its insurance

- 22 carriers, which took considerable time.
- As a result of the delay caused by MPC's insurance carriers, a stipulation and
 order extending the dates and deadlines in the Receiver's case against MPC was
 prepared, filed with the Court, and approved by the Court. At that point, to the
- 26

Because this matter involves pending litigation, Allen Matkins' time entries have been redacted so as not to disclose confidential information relating to the Receiver's litigation strategy or approach to the case. An unredacted copy can be provided to the Court upon request for *in camera* review.

Receiver's surprise, one of the class representatives in the state court actions refused
 to sign the Settlement Agreement, demanding a greater service award for acting as a
 class representative. This issue was addressed through status reports and status
 conferences with Judge Riff, who now has the two related state court cases. After
 the issue was resolved, the Settlement Agreement was amended to provide for a
 larger proposed service award to each class representative, and the agreement was
 then fully executed.

8 A motion for preliminary approval of the Settlement Agreement, including 9 supporting declarations and the proposed class notice, was prepared and filed in the LASC on September 30, 2022. The motion was initially set for hearing on 10 November 22, 2022, but the hearing was recently continued by the LASC to 11 March 28, 2023, and a checklist of concerns with the class settlement notice and 12 13 administration process was provided by the court. The Receiver and class counsel plan to address the concerns raised promptly and request that the hearing date be 14 15 advanced.

The Receiver intends to file a motion for approval of the Settlement
Agreement in this Court once preliminary approval of the class settlement has been
obtained from the LASC and the class notices have gone out to class members. The
reasonable and necessary fees for work in this category total \$63,527.85.

B. <u>Summary of Expenses Requested for Reimbursement</u>

Allen Matkins requests the Court approve reimbursement of \$2,650.39 in outof-pocket costs. The itemization of such expenses is summarized below by
category.

FEES AND COSTS INCURRED AND PAID TO DATE

2 From inception of the receivership through September 30, 2022, the Receiver incurred fees and costs of \$555,939.14, of which amount \$104,170.41 is subject to 3 holdback pending approval of the Receiver's final fee application at the conclusion 4 of the receivership, \$11,157.57 is awaiting the Court's review and approval, and 5 \$442,570.46 has been approved by the Court and paid to date. During the same time 6 7 period, Allen Matkins has incurred fees and costs of \$1,570,799.20, of which 8 amount \$307,117.44 is subject to holdback pending approval of Allen Matkins' final fee application at the conclusion of the receivership, \$74,041.99 is awaiting the 9 Court's review and approval, and \$1,203,918.09 has been approved by the Court and 10 paid to date. 11

IV. THE FEES AND COSTS ARE REASONABLE AND SHOULD BE ALLOWED

"As a general rule, the expenses and fees of a receivership are a charge upon
the property administered." *Gaskill v. Gordon*, 27 F.3d 248, 251 (7th Cir. 1994).
These expenses include the fees and expenses of this Receiver and his professionals,
including Allen Matkins. Decisions regarding the timing and amount of an award of
fees and costs to the Receiver and his Professionals are committed to the sound
discretion of the Court. See *SEC v. Elliot*, 953 F.2d 1560, 1577 (11th Cir. 1992)
(rev'd in part on other grounds, 998 F.2d 922 (11th Cir. 1993)).

21 In allowing fees, a court should consider "the time, labor and skill required, 22 but not necessarily that actually expended, in the proper performance of the duties 23 imposed by the court upon the receiver[], the fair value of such time, labor and skill measured by conservative business standards, the degree of activity, integrity and 24 dispatch with which the work is conducted and the result obtained." United States v. 25 26 Code Prods. Corp., 362 F. 2d 669, 673 (3d Cir. 1966) (internal quotation marks 27 omitted). In practical terms, receiver and professional compensation thus ultimately 28 rests upon the result of an equitable, multi-factor balancing test involving the

"economy of administration, the burden that the estate may be able to bear, the
 amount of time required, although not necessarily expended, and the overall value of
 the services to the estate." *In re Imperial 400 Nat'l, Inc.*, 432 F.2d 232, 237 (3d Cir.
 1970). Regardless of how this balancing test is formulated, no single factor is
 determinative and "a reasonable fee is based [upon] all circumstances surrounding
 the receivership." *SEC v. W.L. Moody & Co., Bankers (Unincorporated)*,
 374 F. Supp. 465, 480 (S.D. Tex. 1974).

As a preliminary matter, the Appointment Order confers on the Receiver
substantial duties and powers, including to conduct such investigation and discovery
as is necessary to locate and account for all receivership assets, take such action as is
necessary and appropriate to assume control over and preserve receivership assets,
and employ attorneys and others to investigate and, where appropriate, institute,
pursue, and prosecute all claims and causes of action of whatever kind and nature. *See* Appointment Order, Section III.

The Receiver promptly determined that experienced, qualified counsel was
necessary due to the size and complexity of the receivership estate and the Court
agreed, specifically approving Allen Matkins' employment. Dkt. No. 152. The
Court also approved the Receiver's proposal to file interim reports and fee
applications on a quarterly basis. *Id*.

20 Allen Matkins has submitted a detailed fee application which describes the 21 nature of the services rendered, and the identity and billing rate of each individual performing each task. See Exhibit A. Allen Matkins has endeavored to staff matters 22 as efficiently as possible, while remaining cognizant of the complexity of issues. 23 The request for fees is based on Allen Matkins' customary billing rates charged for 24 25 comparable services provided in other matters, less a 10% discount. Moreover, Allen Matkins wrote off and did not charge for 1.1 hours of work (\$757.35 in fees). 26 27 The work performed by Allen Matkins was essential to carrying out the

Receiver's Court-ordered duties. The Receiver and Allen Matkins have worked

1	diligently since the Receiver's appointment to preserve and protect the assets of the
2	receivership estate, to investigate potential claims against third parties, and to
3	maximize the funds available for ultimate distribution to investors. Moreover, Allen
4	Matkins seeks payment of only 80% of fees incurred on an interim basis in
5	recognition of the fact that its work in assisting the Receiver is ongoing. Payment of
6	the proposed 20% holdback will be sought at the conclusion of the receivership.
7	Allen Matkins' fees are fair and reasonable and should be approved and paid on an
8	interim basis.
9	V. CONCLUSION
10	Allen Matkins therefore respectfully requests this Court enter an Order:
11	1. Approving Allen Matkins' fees, on an interim basis, of \$71,391.60;
12	2. Authorizing and directing the Receiver to pay 80% of approved fees, or
13	\$57,113.28, from the assets of the Receivership Entities;
14	3. Approving Allen Matkins' costs in the amount of \$2,650.39 and
15	authorizing and directing the Receiver to reimburse such costs in full; and
16	4. For such other and further relief as the Court deems appropriate.
