1 Allen Matkins Leck Gamble Mallory & Natsis LLP ("Allen Matkins"),
2 general counsel to Thomas Hebrank ("Receiver"), the Court-appointed receiver for
3 PWCG Trust, hereby submits this first interim application for approval and payment
4 of fees and reimbursement of expenses ("Application"). This Application covers the
5 period from July 1, 2018, through September 30, 2018 ("Third Application Period"),
6 and seeks interim approval of \$52,544.25 in fees and \$514.86 in expenses, and an
7 order authorizing the Receiver to pay, on an interim basis, 80% of the fees incurred
8 (\$42,035.40) and 100% of expenses incurred.

9 I. INTRODUCTION

10 This equity receivership was established pursuant to the Consent of
11 Defendant PWCG Trust filed on February 12, 2018, and the Judgment as to
12 Defendant PWCG Trust ("Appointment Order") entered on February 16, 2018. Dkt.
13 Nos. 143, 145. Pursuant to the Appointment Order, the Receiver took control of
14 PWCG Trust, its bank accounts, assets, and books and records.

15 The Appointment Order confers full powers of an equity receiver, including
16 full power over all funds, assets, and other property of PWCG Trust, and including
17 its bank accounts, life insurance policies ("Policies"), books and records, and all
18 funds and assets controlled or managed by PWCG Trust. The Appointment Order
19 also authorizes the Receiver to "engage and employ attorneys, accountants, and
20 other persons" to assist him in the performance of his duties. Dkt. No. 145,
21 Section III(F).

22 The Receiver promptly determined that his experienced staff at E3 Realty
23 Advisors, Inc., dba E3 Advisors ("E3"), as well as experienced, qualified counsel
24 was critical due to the number of people involved, the amount at stake for investors,
25 the transactional volume, and the complex issues facing PWCG Trust. Accordingly,
26 the Receiver has cost-effectively used his team at E3 to assist in carrying out
27 receivership duties and engaged Allen Matkins to act as his counsel.

In an abundance of caution, the Receiver sought specific Court approval of Allen Matkins' employment, which was approved on April 10, 2018. Dkt. Nos. 150, 152. The Court also approved the Receiver's proposal to file reports and fee applications on a quarterly basis. *Id.*

II. FEE APPLICATION

This fee application should be read in conjunction with the Receiver's Third Interim Report ("Third Report") filed on December 10, 2018 (Dkt. No. 230), which describes in detail the Receiver's activities during the Third Application Period. This Application seeks interim approval of \$52,544.25 in fees for a total of 82.50 hours worked, and payment on an interim basis of 80% of that amount, or \$42,035.40. The work performed is described task-by-task on Exhibit A and is broken down into the following categories:

Allen Matkins has worked diligently and efficiently to assist the Receiver to address urgent legal issues facing the receivership estate through the transition to a Court-ordered receivership. The firm's work has allowed the Receiver to preserve and protect the substantial value of receivership estate assets, including Policies with death benefits totaling over \$234 million, cash reserves of approximately \$3.3 million, and death benefits received of \$5 million. Allen Matkins' work has assisted the Receiver in carrying out his Court-ordered duties and the firm should be compensated on an interim basis.

1 **III. SUMMARY OF TASKS PERFORMED AND COSTS INCURRED**

2 **A. Categories and Descriptions of Work**

3 1. General Receivership

4 Allen Matkins' work in this category focused on responding to requests for
 5 information from counsel for the Securities and Exchange Commission
 6 ("Commission") in connection with preparing the case for trial, including addressing
 7 matters on which the Receiver may be called to testify. The firm also advised the
 8 Receiver and communicated with counsel for the Commission regarding the
 9 judgments entered against Defendants Pacific West Capital Group, Inc. ("Pacific
 10 West") and Andrew B. Calhoun, IV ("Calhoun"), including issues relating to
 11 enforcement/collection on the judgments. Finally, Allen Matkins advised the
 12 Receiver on tax issues pertaining to the receivership estate. The reasonable and
 13 necessary fees for this category total \$6,126.75.

14 2. Asset Investigation

15 Allen Matkins' time in this category focused on gathering and reviewing
 16 critical documents and information, investigating PWCG Trust's assets, including
 17 potential claims against third parties, and advising the Receiver on actions necessary
 18 to preserve and protect such assets. Among other things, the firm gathered and
 19 analyzed documents produced by Pacific West/Calhoun and BroadRiver Asset
 20 Management, L.P. ("BroadRiver") in response to subpoenas, including
 21 approximately 50 boxes of documents produced by Pacific West/Calhoun. Allen
 22 Matkins also assisted the Receiver in follow up communications with Pacific
 23 West/Calhoun and BroadRiver in order to obtain their compliance with the
 24 subpoenas, including addressing document production cost issues raised by
 25 Calhoun.

26 Allen Matkins also advise the Receiver regarding the scope and strategy for
 27 his forensic accounting and analysis of bank accounts and policies held by PWCG
 28 Trust. The firm also analyzed potential claims to recover from various insiders and

1 third parties. Finally, Allen Matkins advised the Receiver on addressing inquiries
2 and claims made by Calhoun regarding fractionalized interests in certain life
3 insurance policies. The reasonable and necessary fees for work in this category total
4 \$20,226.15.

5 3. Reporting

6 Allen Matkins' time in this category focused on preparing the Receiver's
7 Second Interim Report, which was filed on September 13, 2018. Dkt. No. 204. The
8 Second Interim Report contains a detailed description of the Receiver's activities
9 during the second quarter of 2018, investor communications, pending litigation, and
10 post-receivership receipts and disbursements. The report also includes the
11 Receiver's recommendations for the continued administration of the receivership
12 estate. The reasonable and necessary fees for work in this category total \$3,197.25.

13 4. Operations & Asset Sales

14 Allen Matkins' time in this category focused on advising the Receiver on
15 urgent operating issues facing PWCG Trust, including the need for funding to cover
16 unfunded premium payments, the need to gather data necessary to formulate a long-
17 term strategy for preserving and maximizing the value of the portfolio of policies
18 held by PWCG Trust, and the need to conserve receivership estate resources by
19 minimizing portfolio servicing fees. The firm advised on the transition of portfolio
20 management services from Mills Potoczak & Company ("MPC") to consultant ITM
21 Twentyfirst ("21st"), including handling communications with MPC's counsel.
22 Allen Matkins also assisted in addressing requests for documentation from counsel
23 for an insured in order to establish the Receiver's right to obtain medical records
24 necessary for life expectancy reports. The reasonable and necessary fees for work in
25 this category total \$8,734.50.

26 5. Claims and Distributions

27 Allen Matkins' time in this category focused on analyzing and advising the
28 Receiver regarding claims against the receivership estate and procedures for the

1 administration of claims. Allen Matkins also assisted the Receiver in preparing
2 content for the receivership website, including answers to frequently asked
3 questions and monthly case updates. The firm also assisted in addressing unique
4 investor inquiries.

5 Once preliminary LE reports and valuation data for the PWCG Trust portfolio
6 was provided by 21st, Allen Matkins advised the Receiver regarding the formulation
7 of a long-term plan to maximize the recovery from the portfolio and assisted in
8 initial drafting of the Receiver's motion to approve the long-term plan. The
9 reasonable and necessary fees for work in this category total \$11,897.10.

10 6. Pending Litigation

11 At the time of the Receiver's appointment, there were four civil actions
12 pending in Los Angeles Superior Court in which PWCG Trust was a defendant.
13 Allen Matkins promptly (a) provided counsel for the parties in these cases with
14 notice of the Receiver's appointment and the stay of litigation against PWCG Trust,
15 and (b) filed a notice of the receivership and the litigation stay in each case. The
16 firm communicated with opposing counsel regarding the receivership and stay,
17 investigated the claims and defenses involved, and advised the Receiver on strategy
18 to minimize litigation costs and protect PWCG Trust's interests.

19 During the Third Application Period, Allen Matkins communicated with
20 counsel for the parties and assisted in revising a joint status report. Attorney Ted
21 Fates also attended the Case Management Conference held on August 8, 2018. The
22 reasonable and necessary fees for work in this category total \$2,362.50.

23 B. Summary of Expenses Requested for Reimbursement

24 Allen Matkins requests the Court approve reimbursement of \$514.86 in out-
25 of-pocket costs. The itemization of such expenses is summarized below by
26 category. The majority of the expenses incurred relate to messenger service for
27 court filings, the issuance and service of subpoenas, and the 28 U.S.C. § 754 filings
28 noted above.

IV. THE FEES AND COSTS ARE REASONABLE AND SHOULD BE ALLOWED

"As a general rule, the expenses and fees of a receivership are a charge upon the property administered." *Gaskill v. Gordon*, 27 F.3d 248, 251 (7th Cir. 1994). These expenses include the fees and expenses of this Receiver and his professionals, including Allen Matkins. Decisions regarding the timing and amount of an award of fees and costs to the Receiver and his Professionals are committed to the sound discretion of the Court. See *SEC v. Elliot*, 953 F.2d 1560, 1577 (11th Cir. 1992) (rev'd in part on other grounds, 998 F.2d 922 (11th Cir. 1993)).

In allowing fees, a court should consider "the time, labor and skill required, but not necessarily that actually expended, in the proper performance of the duties imposed by the court upon the receiver[], the fair value of such time, labor and skill measured by conservative business standards, the degree of activity, integrity and dispatch with which the work is conducted and the result obtained." *United States v. Code Prods. Corp.*, 362 F. 2d 669, 673 (3d Cir. 1966) (internal quotation marks omitted). In practical terms, receiver and professional compensation thus ultimately rests upon the result of an equitable, multi-factor balancing test involving the "economy of administration, the burden that the estate may be able to bear, the amount of time required, although not necessarily expended, and the overall value of the services to the estate." *In re Imperial 400 Nat'l, Inc.*, 432 F.2d 232, 237 (3d Cir. 1970). Regardless of how this balancing test is formulated, no single factor is

1 determinative and "a reasonable fee is based [upon] all circumstances surrounding
2 the receivership." *SEC v. W.L. Moody & Co., Bankers (Unincorporated)*,
3 374 F. Supp. 465, 480 (S.D. Tex. 1974).

4 As a preliminary matter, the Appointment Order confers on the Receiver
5 substantial duties and powers, including to conduct such investigation and discovery
6 as is necessary to locate and account for all receivership assets, take such action as is
7 necessary and appropriate to assume control over and preserve receivership assets,
8 and employ attorneys and others to investigate and, where appropriate, institute,
9 pursue, and prosecute all claims and causes of action of whatever kind and nature.
10 *See* Appointment Order, Section III.

11 The Receiver promptly determined that experienced, qualified counsel was
12 necessary due to the size and complexity of the receivership estate and the Court
13 agreed, specifically approving Allen Matkins' employment. Dkt. No. 152. The
14 Court also approved the Receiver's proposal to file interim reports and fee
15 applications on a quarterly basis. *Id.*

16 Allen Matkins has submitted a detailed fee application which describes the
17 nature of the services rendered, and the identity and billing rate of each individual
18 performing each task. *See* Exhibit A. Allen Matkins has endeavored to staff matters
19 as efficiently as possible, while remaining cognizant of the complexity of issues.
20 The request for fees is based on Allen Matkins' customary billing rates charged for
21 comparable services provided in other matters, less a 10% discount. In addition, the
22 firm has written off and not charged for 8 hours of time (\$4,500) during the Third
23 Application Period.

24 The work performed by Allen Matkins was essential to carrying out the
25 Receiver's Court-ordered duties. The Receiver and Allen Matkins have worked
26 diligently since the Receiver's appointment to preserve and protect the assets of the
27 receivership estate, to investigate potential claims against third parties, and to
28 maximize the funds available for ultimate distribution to investors. Moreover, Allen
